RULES AND REGULATIONS.

1. Name of the Society : AMI EDUCATION SOCIETY.

Registered Office : 45 ORCHID CITY GUMTALA
Distt. AMRITSAR

2. Area of Operation : DISTT. AMRITSAR.

3. Membership Fee :

Any person who believes in the aims and objectives of the Society can become the member of the Society.

4. Membership Fees :

Each member will pay Rs.500/- per month towards the fund of the Society.

5. Duration of Membership :

- a. A member ceases to be a member if he dies or become of unsound mind or he resigns from the membership.
- b. If a member fails to attend five continuous meetings of the Society ne ceases to be a member.
- c. If the member will not pay subscription fee for four months continuously he can be removed from the membership by the Executive Committee.
- d. In the case of non payments of subscription fee such member shall have no right to vote in the meeting or nay matter.

6. Meetings :

- a. The meetings of the Executive Committee shall be held whenever necessary by the President or Secretary on a request signed by at least any two Executive Member.
- b. The Executive committee shall at least meet twice in a year.
- c. At least one week notice for the meeting shall be given to the members.

8. Power and Functions of the President :

The President will preside over all the meetings of the Society. Every meeting of the Society will be called on his advise. He will be head of the Society and use all the power given to him from time to time.

9. Power and Functions of Sr. Vice President :

In the absence of the President, the Vice President will use all the power given to the President from time to time in the absence of the President.

10. Powers & Functions of General Secretary :

The Secretary will conduct the correspondence of the Society with the members and authorities. He will conduct the meeting of the Executive Committee and General Body. He will record the proceedings of the meetings and use all the power given to him from time to

11. Power & Functions of the Cashier :

The cashier will collect the donation/ grant from the Govt. or any other institution. He will collect the subscription. He will present the quarterly statement of income & expenditure in the meeting of the Executive Committee. He has power to deposit all collections of behalf of the Society in the Bank and use all the powers given to him from time to time.

12. Funds :

The funds of the Society shall consist of subscription from members, donation from public or grant from the Govt./ Semi Govt. or other institution.

13. Banks :

The bank of the Society will be any nationalized bank decided by the Governing Body.

14. Election :

The election of the office bearers will be held every three years by the majority of votes.

15. Accounts :

Accounts will be maintained from April to March and the accounts will be maintained by the President and Secretary with any other member of the Society. The bank account will be opened and operated by the President & Cashier jointly and in the absence of the President, the Secretary and Cashier will open and operate the bank account jointly.

16. Legal Matters :

The Society will settle legal matters through the name of the President or Secretary.



18. Dissolution of Society :


